Re: Public Input on the Proposed Pebble Mine Project (POA-2017-271)

Dear Mr. McCoy, Ms. Newman, and Colonel Borders:

As businesses that value and depend on the future productivity of the Bristol Bay watershed, we are writing with regards to the U.S. Army Corps of Engineers' Draft Environmental Impact Statement (EIS) for the proposed Pebble Mine. Bristol Bay is home to America's largest and most valuable wild salmon fishery, providing a renewable source of jobs and income for thousands of Americans. Given the ecological sensitivity of the Bristol Bay watershed, it deserves the most rigorous, science-based environmental impact assessment possible. Anything less jeopardizes the economic stability of our industries and bottom lines. We respectfully request that the Army Corps suspend its review of the Pebble Limited Partnership's Clean Water Act 404 permit application and protect Bristol Bay from this risky and irreversible mining project.

It is widely recognized that Bristol Bay is a national treasure and is the cornerstone of Alaska's seafood industry, which is known for sustainable, nutritious, premium quality seafood. Bristol Bay's salmon fishery not only supports 14,000 jobs and \$650 million in annual income, but it also generates over a billion dollars of sales in other business sectors, including food service, retail, sport fishing, and outdoor recreation. To jeopardize this renewable economic engine for a 20-year mining project makes no sense both in principle and on paper.

In previous communications to the Army Corps, Businesses for Bristol Bay has requested that the Army Corps conduct a fair, rigorous, science-based permitting process. We have also shared our concerns about the Army Corps' rushed timeline and missing information in the Pebble Partnership's permit application. The Draft EIS released on February 20th only reinforces our concerns; it was based on an incomplete Scoping Report and fails to capture and evaluate the Pebble Mine's true potential impacts on the ecological health and economic productivity of Bristol Bay. We find it especially troubling that the Draft EIS failed to include:

- **A thorough and realistic analysis of a potential tailings dam failure.** The tailings dam failure assessment in the Draft EIS is inadequate and just looks at a small fraction of what’s actually possible and likely to occur over the lifespan of the mine. Given that the tailings dam will be a permanent structure that exists in Bristol Bay in perpetuity, it is critical that the Army Corps look at the full range of impacts and increased probability of failure over time.
- **An economic analysis of potential impacts to already existing industries and businesses.** This includes but is not limited to the outdoor recreation and seafood industries, which depend on Bristol Bay’s intact habitat and clean water. Given Bristol Bay’s reputation for pristine wilderness and pure, wild seafood, the Draft EIS must look at Pebble’s impacts on the public perception and market value of the “Bristol Bay” brand.
- **A mitigation plan that includes compensatory mitigation for Pebble’s adverse impacts on the Bristol Bay watershed.** The Pebble Mine threatens thousands of already existing jobs, businesses, and industries that depend on the productivity of Bristol Bay’s salmon populations. The Draft EIS needs to include details about how Pebble will address its adverse impacts on the Bristol Bay watershed and the businesses that depend on it.

Given the continued shortcomings of the Army Corps’ permitting process, Businesses for Bristol Bay once again asks the Army Corps to suspend its review until the Pebble Partnership delivers sufficient environmental baseline and economic data as well as a comprehensive mitigation and reclamation plan. As businesses that are required to go through permitting on a regular basis, it is concerning to see the Army Corps stray from standard procedure and give preferential treatment to a junior mining company that still has not submitted a complete permit application. The NEPA process was created to ensure transparency and protection of the American public, especially in places like Bristol Bay that provide irreplaceable public goods and benefits. The undersigned businesses ask that the Army Corps restart its review of the Pebble Partnership’s permit application and hold this project to the highest bar. The future of our businesses, employees, and industries depend on it.
